

RESOLUTION MEMORIALIZING THE LATE JANE S. GLENN.

WHEREAS, Jane S. Glenn of Roanoke, an outstanding public servant and attorney, died November 20, 2007 after a long and courageous battle with cancer; and

WHEREAS, Jane S. Glenn is offered to the memory of our Association as a highly esteemed and respected lawyer, mentor, friend and colleague; and

WHEREAS, Jane S. Glenn was born in Harrisonburg, Virginia, daughter of Paul and Sabine Glenn; graduated from the College of William and Mary and of the T.C. Williams School of Law at the University of Richmond, where she was a member of the McNeill Law Society and Associate Editor of the Law Review; she was admitted to the Virginia State Bar in 1983 and served as a Law Clerk to the Honorable Jackson L. Kiser of the United States District Court for the Western District of Virginia; she joined the law firm of Gentry Locke, Rakes & Moore where she advanced to partner before forming her own firm, Fishwick, Jones and Glenn; and

WHEREAS, in 1994, Jane was endorsed by the Roanoke City Bar Association for a vacancy on the 23rd Judicial Circuit for a Circuit Court judgeship because of her intellect and demeanor; and at the time of her death, Jane was in active practice with the firm of Glenn, Robinson & Cathey; and

WHEREAS, Jane served with distinction two terms on the Bar Council of the Virginia State Bar, as well as on the Executive Committee of the Virginia State Bar, on the Board of Directors of the Virginia Association of Defense Attorneys and as Chapter President of the Virginia Women Attorney's Association; and at the time of her death she was serving as a Master of the Bench of the Ted Dalton American Inn of Court and as a Member of the Executive Committee of that Inn; and

WHEREAS, Jane gave her time and efforts to a wide variety of community and volunteer activities, including serving in the Virginia Bar Association Mentor Program for many years; as a volunteer teacher for Roanoke City Schools; as a past member of the Board of Directors of the YWCA and a past member of the Legal Aid Society of the Roanoke Valley; and

WHEREAS Jane was a trusted friend and mentor to countless attorneys now in practice in and around the Roanoke Valley and enjoyed an exceptional reputation across the Commonwealth of Virginia as an advocate for her clients and was professional in the finest sense of the word; and

WHEREAS, Jane S. Glenn will be fondly remembered and greatly missed by her parents, Paul and Sabine Glenn of Roanoke; brothers Paul Glenn, Jr. of Roanoke and Todd Glenn of Cary, N.C.; her sister in law Mimi Glenn, her nieces, Chelsea, Lindsey and Sarah; her nephew, Wade; and her extended family; her best friend, Melissa Robinson; her law partners, and other family, friends and colleagues both within and outside the Bar;

NOW, THEREFORE, BE IT RESOLVED, that the Roanoke Bar Association laments the passing of Jane S. Glenn, and holds her memory and her contributions to this Association, to this community, and to the cause of justice in the highest regard; and

BE IT FURTHER RESOLVED that copies of this resolution be furnished to the Circuit Courts of the City and County of Roanoke, the City of Salem and the United States District Court for the Western District of Virginia, Roanoke Division, with motions that the resolution be spread upon the permanent common law order books of those courts; and that copies of this resolution be furnished to her family to communicate the esteem in which the Roanoke Bar Association holds her and her memory and the Association's profound sorrow at her passing.
