

## A RESOLUTION MEMORIALIZING THE LATE KENNETH C. KING, JR.

WHEREAS, Kenneth Callaway King, Jr. passed away at age 68 in Charlottesville, Virginia, on September 12, 2010; and

WHEREAS, Mr. King was born in Milwaukee, Wisconsin, on February 17, 1942, and was the son of the late Kenneth Callaway King, Sr. and Annetta Brown King; Ken graduated from Riverside Military Academy, from Lawrence College and from the University of Minnesota Law School; and

WHEREAS, Mr. King had a lifelong passion for aviation and was a distinguished graduate of the United States Air Force Flight School at Vance Air Force Base in Enid, Oklahoma and Mr. King served honorably as a Stratofortress pilot in Viet Nam with the U.S. Strategic Air Command in North Dakota. He retired as a United States Air Force Major; and

WHEREAS, Mr. King was a member of the Order of the First Families of Virginia, and he served as Honorary President for Life. He was also a member of the Sons of the American Revolution and served as State President of that organization; and

WHEREAS, Mr. King was a founder and former president of the Commonwealth Games of Virginia, a long time board member and past president of the Virginia Special Olympics, a member of the Roanoke and Virginia State Bar Associations, and past president of the Roanoke Valley Estate Planning Council; and

WHEREAS, Mr. King practiced law with honor and grace in Roanoke for 38 years with, among others, Key, Tatel & King; King & Higgs and King Law Group. He also served as a substitute judge for the Virginia 23<sup>rd</sup> Judicial District and General District Court; and

WHEREAS, Mr. King is survived by his wife of 44 years, Martha Richardson King, of Charlottesville, Virginia, a son, Robert Wilson King, a daughter, Juliet King Daum and his five beloved grandchildren, Henry Callaway Daum, Charlotte Page Daum, Griffin McAfee King, Alexandra Elizabeth King and William Tazewell King.

NOW, THEREFORE, BE IT RESOLVED that the Roanoke Bar Association laments the passing of Kenneth Callaway King, Jr., and holds his memory and his contributions to this association, to this community and to the cause of justice in high regard; and

BE IT FURTHER RESOLVED that copies of this resolution be furnished to the Circuit Courts of the City and County of Roanoke and the City of Salem and the United States District Court for the Western District of Virginia, Roanoke Division, with motions that the resolution be spread upon the permanent common law order books of those courts; and that copies of this resolution be sent to Kenneth Callaway King, Jr.'s family to communicate the esteem in which the Bar Association holds Ken and his memory and to convey the Association's sorrow at his passing.
