

RESOLUTION MEMORIALIZING THE LATE LAWRENCE C. MUSGROVE, JR.

WHEREAS, Lawrence C. Musgrove, Jr., the epitome of the "citizen lawyer" died on January 16, 2012; and,

WHEREAS, this resolution is made for the purpose of memorializing the passing of Mr. Musgrove, a member of this Association and of the Virginia State Bar.

Mr. Musgrove was born on February 14, 1927 in Lynchburg, Virginia. He was reared in a Presbyterian orphanage. He worked as a laborer while still a young boy. He served in the Army Air Corps in World War II. He retired as a Major from the Air Force Reserves. After World War II, he attended VPI. He attended Washington and Lee Law School and graduated cum laude in 1954. He was also President of his class at Washington & Lee. After graduation, he went to work for the law firm of Martin, Martin and Hopkins. He became a partner in 1956.

Mr. Musgrove left Martin, Martin and Hopkins to join the staff of the United States Attorney's office for the Western District of Virginia. Upon his retirement as an Assistant United States Attorney, J. Edgar Hoover presented him with a Letter of Commendation for his service.

Mr. Musgrove was a successful businessman as well as lawyer. In 1997, Mr. Musgrove started Lawrence C. Musgrove Associates. Mr. Musgrove served as administrator, counsel and consultant to multi-employer health and welfare, pension, annuity and training funds. Mr. Musgrove was a director of Salem Bank and Trust and Rice Bottling Companies, among others.

Mr. Musgrove was a member of Forest Park Baptist Church, The Kazim Shriners of North America, the Scottish Rite of Freemasons and was a Master Mason of Lakeland Lodge No. 190 of Roanoke.

Mr. Musgrove gave his time and efforts to a wide variety of community and volunteer activities including the Roanoke Bar Association and the Legal Aid Society of the Roanoke Valley.

Mr. Musgrove was a loving husband, a good father, a first rate lawyer, a patriot and a citizen dedicated to making this community and this Commonwealth a better place.

Mr. Musgrove will be fondly remembered and greatly missed by his wife, Barbara Musgrove, his children Lawrence C. Musgrove, III, Marian Shockley, Karen Musgrove and Jackie Hassan, his grandchildren and great grandchild and other friends, family and colleagues both within and outside the Bar.

NOW THEREFORE, BE IT RESOLVED, that the Roanoke Bar Association laments the passing of Lawrence C. Musgrove and holds his memory and his contributions to this Association, to this community, and to the cause of justice in the highest regard; and

BE IT FURTHER RESOLVED, that copies of this resolution be furnished to the Circuit Courts of the City and County of Roanoke, the City of Salem and the United States District Court for the Western District of Virginia, Roanoke Division, with motions that the resolution be spread upon the permanent common law order books of those courts; and that copies of this

resolution be furnished to his family to communicate the esteem in which the Roanoke Bar Association hold him and his memory and the Association's profound sorrow at his passing.
